- Anyone who has previously been removed as a trustee by the Charity Commission, the Scottish charity regulator or the High Court due to misconduct or mismanagement
- Anyone who has been removed from management or control of any body under section 34(5)(e) of the Charities and Trustee Investment (Scotland) Act 2005 (or earlier legislation)
- Anyone who is disqualified from being a trustee by an order of the Charity Commission under section 181A of the Charities Act 2011.
